

## PC-2024-069 WTCA 25/02 - Porlock Recreation Ground, Parsons Street, Porlock, Somerset, TA24 8QJ

Proposal: Works to trees in a conservation area: removal of weight from overhanging branches to Purple Beech (Tag 44), together with, the felling of 5no. trees (Silver Birch – Tag 51, Red Horse Chestnut – Tag 29, Norway Maple - Tag 22, Horse Chestnut – Tag 27 and Cherry Tree – Tag 70).

The committee invited Cllr. S McCanlis to speak as applicant on behalf of Porlock Recreation Ground. A brief overview of the application and history of previous tree surveys was presented to the committee.

The committee raised concern with the application as there was limited information on the application that supported the felling and that it had observed some of the trees, reported to be dead, were now showing signs of life.

The committee recommended to 'object' the application due to the lack of information about why the trees need to be felled and requested that the planning officer reviews the trees and that the Recreation Ground resubmits the application should it be necessary.
