6. 6/27/24/003 - THE PAVILION, PORLOCK RECREATION GROUND, PORLOCK, TA24 8QJ

Proposed demolition of a disused toilet block, erection of an extension to the pavilion along with subsequent alterations and renovation measures.

Porlock Parish Council support this proposal for the following reasons. The alterations will enhance the visual aspect of the building within the conservation area. The proposal will be positive for the community and visitors alike. Upgrading the changing room facilities will provide long term insurance to the teams as they progress the league system. It will provide long term security to the recreation ground allowing events etc. to be held for the foreseeable future.

7. GDO 24/06 - LAND AT NORTH COMMON WOOD, SOUTH OF A39, OARE, EX35 6NG

Prior notification for the installation of a 25m high lattice tower supporting 3 no. antennas and 2 no. 0.6m dishes; 2 no. equipment cabinets, 1 no. meter cabinet, a generator and associated ancillary development enclosed by a 1.1 metre high stockproof fence, for the Shared Rural Network project on behalf of Cornerstone.

Porlock Parish Council give a 'no objection' to this application. The Council feel that communication towers such as this will have a visual impact on the surroundings but hopefully can be kept to a minimum.
