6. 6/27/24/002 1 & 2 Lane Head, Porlock Weir, Porlock. TA24 8PB

Proposed Fire reinstatement of 2no residential cottages to include rebuild of roof structure and conversion of roof from thatch to natural slate, retention of remaining external walls and full internal refurbishments. Also, use of adjacent field for temporary site compound.

Porlock parish council support this proposal for the following reasons. The rebuilding of these cottages will give the local persons displaced by the fire their homes back. Replacing the thatched

roof with slates will not detract from lane head as the other dwellings do not feature a thatched roof and a slate roof is a better option from a safety perspective. Noted that the adjacent field used as a site compound must adhere to highways instructions and that the field reverts back to original use after the build.

7. WTCA 24/04 SWISS LODGE, HAWKCOMBE, PORLOCK, MINEHEAD, TA24 8QN Proposed works to tree in a conservation area: 30% crown reduction of T1-Sycamore.
