#### 1. Apologies

Apologies were received from Cllr. Hancock and Cllr. Hall due to family commitments.

#### 2. <u>Declarations of Interest and Disclosable Pecuniary Interest Dispensations</u>

Cllr. Mrs. Gable and Cllr. Mrs. Ellicott both noted their interest in Item 7, Planning Application WTCA 19/04 Porlock Recreation Ground, Parsons Street.

#### 3. The Minutes

It was unanimously **RESOLVED** that the minutes as previously circulated of the meeting held on the 13<sup>th</sup> March 2019 be approved and signed as a correct record with the following amendment:

#### Cllr. Mrs, Mills (WSC)

Cllr. Mrs. Mills advised that West Somerset and Taunton Council have just passed a motion to declare a Climate Emergency, the result is to create a carbon neutral Council by 2030. As a result of this there is currently an ongoing investigation into the **consideration** of installing EV (Electrical Vehicle) points throughout the County, the local garage situated on Porlock High Street is a potential site and Doverhay Car Park will also be a consideration.

#### 4. Matters for report not on the Agenda

#### West Somerset Flood Group

The Chairman approached the Council for approval of a payment of £5.00 for the subscription for West Somerset Flood Group Website. It was **UNANIMOUSLY APPROVED** as the council has been a member of this organisation for ten years and has made good use of their advice and services during this time.

#### Porlock Fire Station Visit

Following the Parish Council meeting in November 2018 regarding the changes to take place at Porlock Fire Station, SM Adrian Woollaston from Devon & Somerset Fire and Rescue Service has extended an invitation to all Councillors who would like to see a demonstration of the new vehicle in action and if there were any areas in the immediate vicinity which would require extra consideration in order to improve response times. A mutually agreeable date is to be arranged shortly.

#### Bus Contract for 2019 - 2020

Following the meeting to review the Bus Contract held on the 18<sup>th</sup> February 2019 at Porlock Village Hall it was **UNANIMOUSLY APPROVED** to sign and approve the contract.

The meeting was adjourned for Public Participation.

#### 5. Public Participation

A local resident advised that they are attending this meeting as a representative of the number 10 Bus Service Committee and would like to note they have requested improved signage with a prominent display area.

#### Cllr. Mrs, Mills (WSC)

#### **Doverhay Toilets Business Rates**

Cllr. Mills advised she is to review the Business Rates previously issued and will report back at a later date.

#### **Picnic Site Toilets**

Cllr. Mills advised that following reports that the public building adjacent to the Picnic site was due to be sold to Falcon Housing Association and be demolished, she is now pleased to report that Mr and Mrs Keal have now taken ownership of the building to incorporate their family business.

#### **Library Business Rates Update**

Cllr. Ware reported that this will need to be reviewed as Doverhay Manor is due to lose its Charitable status which could potentially have a knock-on effect with the PPC status. One line of investigation is to confirm if all three assets at the School Centre can be combined, Cllr. Mrs. Mills and Cllr. Ware will review at a later date.

#### **Abattoir Site**

I spoke to Walsingham Planners this week and can report that they have given ENP an extension of time regarding a decision and it looks likely that the meeting will be held on the 2nd May. They also confirmed that their clients would not be opposed to the idea of them paying for traffic calming measures adjacent to the site, but it would depend on the overall costs involved. As I have previously indicated I am happy to look into this proposal and report back to the Parish Council.

The Chairman advised that Dean Kinsella from ENP is keen to hold a further Public Consultation to discuss the development if it was required.

#### **Picnic Site**

I am pleased to report that Matt Keale has completed on the purchase of the building adjacent to the Picnic Area.

I spoke to Falcon Housing who, as you are aware, are trying to buy the Picnic Area and they are pleased to hear this news because it suggests to them that WSC are serious about selling the Picnic Site and they are proceeding with negotiations.

It was reported that Cllr. Hancock had recently liaised with C J Lynch and requested a guide price subject to survey results. As previously indicated, there is a lot of work to be done with the owner of the land, solicitor's fees, etc.
